### 1. Introduction

ThalesNano Energy Zrt was established at the end of November 2017, mainly to develop, sell and market H-Genie chemical engineering equipment, mainly for export. The H-Genie is an electrochemical hydrogen generator capable of producing high purity hydrogen over a wide pressure range, mainly for laboratory needs. In parallel, the market assessment of electrochemical technology for the conversion of carbon dioxide and the exploration of business opportunities has been initiated.

On 1 February 2022, the ownership structure changed and the company changed its name to eChemicles Zrt. As part of the transformation, the H-Genie business was sold and at the same time the ownership of the industrial property rights previously held by ThalesNano Zrt. and the University of Szeged (SZTE) related to the carbon dioxide technology developed by ThalesNano Zrt. At the same time, it acquired exclusive exploitation rights for the industrial property rights held by SZTE under a licence agreement.

Since the transformation, the company has been working to further develop and commercialise its carbon conversion technology by attracting tender funding and developing its industrial property portfolio. It has successfully applied for domestic and direct EU R&D programmes, raised funds and started development activities. The aim is to create a containerised prototype of the carbon dioxide conversion electrolysis technology and to start commercialisation activities. Investor funding has also been raised to accelerate the commercialisation process. The development activity is taking place at the Science Park in Szeged. The above mentioned projects are hereinafter referred to collectively in this Information Note as "**Projects**".

# 3. Rights of data subjects whose personal data are processed in the course of the processing

As a data subject whose personal data is processed, you have the following rights in relation to the processing. Please note that you may exercise the rights set out below primarily against the controller. For the purposes of this processing, eChemicles Zrt. is the controller.

### Your rights as a data subject in relation to data processing

- right to information,
- right of access,
- the right to rectification,
- the right to erasure, "the right to be forgotten",
- the right to limit,
- the right to protest,
- your right to data portability,
- the right to withdraw consent,
- right to complain,
- the right to judicial redress.

### **Right to information**

### General rules on the information of the data subject and the right to information

Before the processing starts, the data subject must be informed in detail by the controller at the latest when the personal data of the data subject are obtained. In relation to the processing, the information contained in this privacy policy.

The controller is responsible for providing prior information. In addition to the above prior information, you may request information from the controller at any stage of the processing, as follows. In this case, the controller shall provide the information without undue delay and at the latest within 25 days. The 25-day period may be extended by a maximum of 2 months only in justified cases.

The controller may refuse to provide the information only if it proves that the data subject cannot be identified.

If the controller does not take action, i.e. does not comply with the obligation to provide information, it must inform the data subject within 25 days of the failure to take action, the reasons for the failure to act and the data subject's right to lodge a complaint or to bring a case before a court. Details of how to lodge a complaint or seek judicial redress are set out below.

The information and action shall be provided by the controller to the data subject free of charge. However, the controller may exceptionally charge a reasonable fee or refuse to provide the information and take action where the data subject's request is manifestly unfounded, repetitive or excessive.

### Right of access of the data subject

The data subject shall have the right to obtain from the controller feedback as to whether or not his or her personal data are being processed and, if such processing is taking place, the right to access the personal data and the following information:

On the basis of the right of access, the data subject shall be informed, upon request, of the following information: a) the purposes of the processing; b) the categories of personal data concerned; c) the recipients or categories of recipients to whom or which the personal data have been or will be disclosed, including in particular recipients in third countries, or. (e) the right of the data subject to obtain from the controller the rectification, erasure or restriction of the processing of personal data concerning him or her and to object to the processing of such personal data; (f) the right to lodge a complaint with the supervisory authority (NAIH); (h) the existence or absence of automated decision-making, including profiling, and, at least in those cases, the logic used and clear information on the significance of such processing and its likely consequences for the data subject.

The data controller shall provide the data subject with a copy of the personal data processed. For additional copies requested by the data subject, the controller may charge a reasonable fee based on administrative costs.

Where the data subject has made the request by electronic means, the information shall be provided in a commonly used electronic format, unless the data subject requests otherwise.

### **Right to rectification**

The data subject shall have the right to obtain from the controller, upon his or her request and without undue delay, the rectification of inaccurate personal data relating to him or her. Having regard to the purposes of the processing, the data subject shall have the right to obtain the rectification of incomplete personal data, including by means of a supplementary declaration.

### Right to erasure, "right to be forgotten"

As a data subject, you have the right to obtain from the controller the erasure of personal data relating to you without undue delay, and the controller has the obligation to erase personal data relating to you without undue delay, if one of the following grounds applies:

(a) the personal data are no longer necessary for the purposes for which they were collected or otherwise processed;

(b) where the processing is based on the data subject's consent (e.g. sending a newsletter) and the data subject withdraws his or her consent to the processing and there is no other legal basis for the processing;

(c) the data subject objects to the processing and there are no overriding legitimate grounds for the processing;

d) the personal data have been unlawfully processed;

(e) the personal data must be erased in order to comply with a legal obligation under Union or Member State law to which the controller is subject;

f) the personal data were collected in connection with the provision of information society services.

Where the controller has disclosed the personal data and is required to erase it pursuant to paragraph 1, it shall take reasonable steps, including technical measures, taking into account the available technology and the cost of implementation, to inform the controllers that process the data that the data subject has requested the deletion of the links to or copies of the personal data in question.

The controller shall not be obliged to comply with a request for erasure in the above cases where the processing is necessary: a) for the exercise of the right to freedom of expression and information; b) to comply with an obligation under Union or Member State law to which the controller is subject to which the processing of personal data is subject; or c) to comply with a request for erasure in the following cases. (c) on grounds of public interest in the sphere of public health; (d) for archiving purposes in the public interest, scientific or historical research purposes or statistical purposes, where the right of erasure would be likely to render impossible or seriously impair such processing; or (e) for the establishment, exercise or defence of legal claims.

### **Right to restriction of processing**

The data subject shall have the right to obtain, at his or her request, the restriction of processing by the controller if one of the following conditions is met: (a) the data subject contests the accuracy of the personal data, in which case the restriction shall be for a period of time which allows the controller to verify the accuracy of the personal data; (b) the processing is unlawful and the data subject opposes the erasure of the data and requests instead that the use of the data be restricted; (c) the controller no longer needs the personal data for the purposes of the processing but the data subject requires them for the establishment, exercise or defence of legal claims; or (d) the data subject has objected to the processing, in which case the restriction shall apply for a period of time until it is established whether the legitimate grounds of the controller override the legitimate grounds of the data subject.

Where processing is restricted on the basis of the above, such personal data may be processed, except for storage, only with the consent of the data subject or for the establishment, exercise or defence of legal claims or for the protection of the rights of another natural or legal person or of an important public interest of the Union or of a Member State.

The data controller shall inform the data subject whose request for restriction of processing has been made on the basis of the above in advance of the lifting of the restriction.

## Obligation to notify the rectification or erasure of personal data or the restriction of processing

The controller shall inform any recipient to whom or with which the personal data have been disclosed of the rectification, erasure or restriction of processing, unless this proves impossible or involves a disproportionate effort.

The controller shall inform the data subject of these recipients at his or her request.

### The right to data portability

The data subject shall have the right to receive personal data concerning him or her which he or she has provided to a controller in a structured, commonly used, machine-readable format and the right to transmit such data to another controller without hindrance from the controller

to which he or she has provided the personal data, where: a) the processing is based on the data subject's consent (e.g. sending a newsletter) or on the performance of a contractual obligation between the parties; and b) the processing is carried out by automated means.

In exercising the right to data portability as set out above, the data subject shall have the right to request, where technically feasible, the direct transfer of personal data between controllers.

The exercise of the right to data portability must not prejudice the right to erasure. The right to data portability must not adversely affect the rights and freedoms of others.

### **Right to object**

As a data subject, you have the right to object to the processing of your personal data at any time on grounds relating to your particular situation. In such a case, the controller may no longer process the personal data unless the controller demonstrates compelling legitimate grounds for the processing which override the interests, rights and freedoms of the data subject or for the establishment, exercise or defence of legal claims.

Where personal data are processed for direct marketing purposes (e.g. sending marketing mail to customers), the data subject has the right to object at any time to the processing of personal data concerning him or her for such purposes, including profiling, where it is related to direct marketing. If the data subject objects to the processing of personal data for direct marketing purposes, the personal data may no longer be processed for those purposes.

### Right to withdraw consent

Where the legal basis for processing is the data subject's consent (e.g. sending a newsletter for marketing purposes), the data subject has the right to withdraw his or her consent at any time. However, the withdrawal of consent does not render the processing prior to the withdrawal unlawful.

### 4. Data security

### Storage of personal data and security of processing

The IT infrastructure, storage and other data storage facilities of eChemicles Zrt. are located at its headquarters and premises.

The IT tools and solutions used for data processing, in particular security systems, are selected and used in such a way that the personal data processed are accessible to those authorised to access them, their authenticity and authentication are ensured, their integrity is verifiable and they are protected against unauthorised access.

We will take appropriate measures to protect your personal data, in particular against unauthorised access, alteration, data breach, data theft, data leakage, disclosure, transmission, alteration, deletion or destruction, accidental destruction or damage and inaccessibility due to changes in the technology used.

In order to protect the data files managed in its records, eChemicles Zrt. ensures by means of appropriate technical solutions that the stored data cannot be directly linked or attributed to the data subject, except in the case of legal authorisation.

In view of the current state of the art, we ensure the security and protection of our data processing by taking technical, organisational and organisational measures that provide an adequate level of protection for your personal data.

The IT system and network of eChemicles Ltd. and its partners are protected against dangerous human (e.g. fraud, espionage, sabotage, vandalism, computer viruses, computer intrusions, etc.), natural (e.g. fire and flood) or other (e.g. service outages, etc.) harmful intrusions. eChemicles Ltd. ensures the security of its data through server and software level protection procedures and services.

eChemicles Zrt. protects the processing of personal data so that only those who are entitled to access it have access to it (confidentiality), the accuracy and completeness of personal data and the method of processing (integrity), ensures that when authorized users need the personal data, they can actually access the data and that they are available (availability).

We inform the data subjects that personal data is partly transmitted to eChemicles Zrt. via the internet. Regardless of the protocol used (e-mail, web, ftp, etc.), the security of data and electronic messages transmitted over the Internet is vulnerable to network threats that could be used to commit fraudulent activity, to dispute a contract, or to disclose or modify information. To eliminate such threats, eChemicles Ltd. will take all reasonable security measures.

### The data breach and its handling

According to the European Data Protection Regulation (GDPR), **a data breach is a** breach of security that results in the accidental or unlawful destruction, loss, alteration, unauthorized disclosure of, or access to, personal data transmitted, stored or otherwise processed. A data breach is therefore any event or situation where your personal data could fall into unauthorised hands.

In the event of a data breach, we will notify the incident to the competent supervisory authority without undue delay, but no later than 72 hours after the data breach has come to our attention, or inform you as the data subject if the data breach is likely to result in a risk to the rights and freedoms of natural persons.

### 5. Legal remedies, right of complaint, judicial remedies

That is, what can you do if you think your personal data is not being processed correctly?

### **Right to complain**

As a data subject, you have the right to lodge a complaint with a supervisory authority, in particular in the Member State of your habitual residence, place of work or place of the alleged infringement, if you consider that the processing of personal data relating to you infringes the law. The competent supervisory authority in Hungary is the National Authority for Data Protection and Freedom of Information (NAIH).

The exercise of the right to complain does not exclude the possibility for you, as the data subject, to seek other administrative or judicial remedies if you consider that your personal data are being processed in a way that is unlawful. Thus, even if you exercise your right to complain, you may also exercise your right to seek administrative or judicial redress at the same time.

# Right to judicial remedy against a decision of the NAIH or another supervisory authority

If you have applied to the supervisory authority (NAIH) in relation to your data processing and the authority has taken a decision in your case, you, as the data subject, have the right to seek judicial remedy against this decision, i.e. to challenge the decision in court. You have the right to judicial remedy even if the competent supervisory authority (NAIH) does not deal with the complaint or does not inform the data subject of the procedural developments or the outcome of the complaint within three months.

Proceedings against the supervisory authority (NAIH) must be brought before the courts of the Member State where the supervisory authority is established.

### Right to judicial remedy against the controller or processor

As a data subject, you have the right to judicial remedy if you consider that your rights in relation to the processing of your personal data have been infringed as a result of the unlawful processing of your personal data. The exercise of the right to judicial remedy does not exclude the possibility for you, as the data subject, to seek other administrative or judicial remedies or to exercise your right to lodge a complaint if you consider that your personal data are being processed unlawfully.

Proceedings against the controller or processor shall be brought before the courts of the Member State in which the controller or processor is established. In the case of eChemicles Zrt., the courts of the place of establishment shall be the courts of Hungary. While the competent court according to the seat of eChemicles Zrt. is the Szeged District Court or, in case of special jurisdiction, the Szeged Regional Court.

A judicial remedy may also be brought before the courts of the Member State in which the data subject has his or her habitual residence, unless the controller or processor is a public authority of a Member State acting in its exercise of official authority.

### Liability and damages

In other words, how is the controller or processor liable to the data subject in the event of damage?

If the inappropriate processing has caused damage to you as the data subject, the controller is liable for compensation for the damage. Damage can be said to have occurred if the processing was unlawful or in breach of contract and the data subject suffered financial loss as a result. In the case of unlawful processing, the data subject may also claim damages.

You may pursue your claim for damages or compensation primarily against the controller. The processor is only liable for damages if it has only breached the rules applicable to it or has not followed the lawful instructions of the controller. In other words, the processor is not liable for errors made by the controller.
